

Qisda actively participates in various associations to strengthen the industrial linkage and development. The company continuously focusing important issues<sup>1</sup> including M&A, industrial development, technology innovation, corporate governance, and sustainable environment.

Peter Chen, the Chairman of Qisda, has served as the Chairman of Taiwan M&A and Private Equity Council (**MAPECT**) from 2022 to 2023. He has continuously built a perfect M&A and private equity investment environment in Taiwan, improved the relevant legal environment, put forward policy suggestions to the competent authorities, and conducted extensive exchanges and cooperation with relevant international organizations.

In response to important international initiatives and the impact of climate change, Qisda actively participates in climate action organizations. In 2022, Qisda joined RE100 and the Science Based Targets initiative (SBTi). By February 2024, Qisda has been validated by the SBTi, aligning with the United Nations Climate Summit's Paris Agreement to limit global average temperature rise to 1.5°C. Qisda commits to reduce absolute scope 1 and 2 GHG emissions 42% by 2030 from a 2021 base year, and commits to reduce absolute scope 3 GHG emissions 25% within the same timeframe.

Qisda has committed to reducing supply chain emissions by 30% by 2030, to fully use renewable electricity by 2040, and to reach net zero emissions by 2050, so as to keep in line with international trends and practice the goal of corporate sustainability.

In 2023, Qisda participated in approximately 30 public associations at home and abroad, with a total expenditure of about NT\$ 6.52 million, and the cumulative total expenditure from 2020 to 2023 was NT\$ 12.81 million.
